The Tecumseh Area Chamber of Commerce and/or the City of Tecumseh and their agents, successors and/or assigns, shall not be liable for any damages whatsoever, including property damage and/or personal injury to any Vendor, which may occur on or about any part of the properties being used for the City Wide Garage Sale, regardless of how much injury or damage may have occurred.

City Wide Garage Sale Safety Requirements

Vendor hereby agrees to comply with the Garage Sale rules, especially health and safety regulations.

Indemnification
